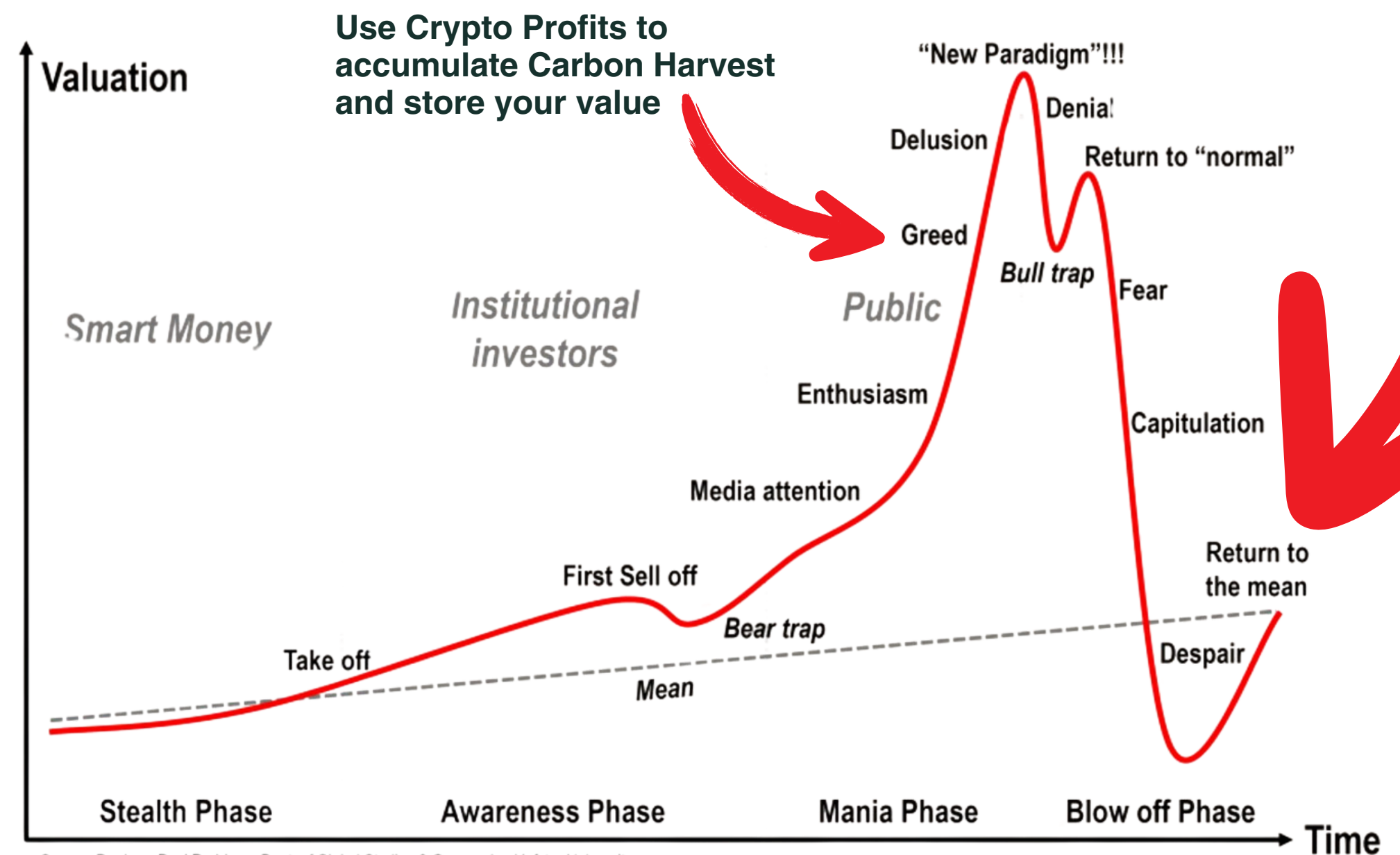

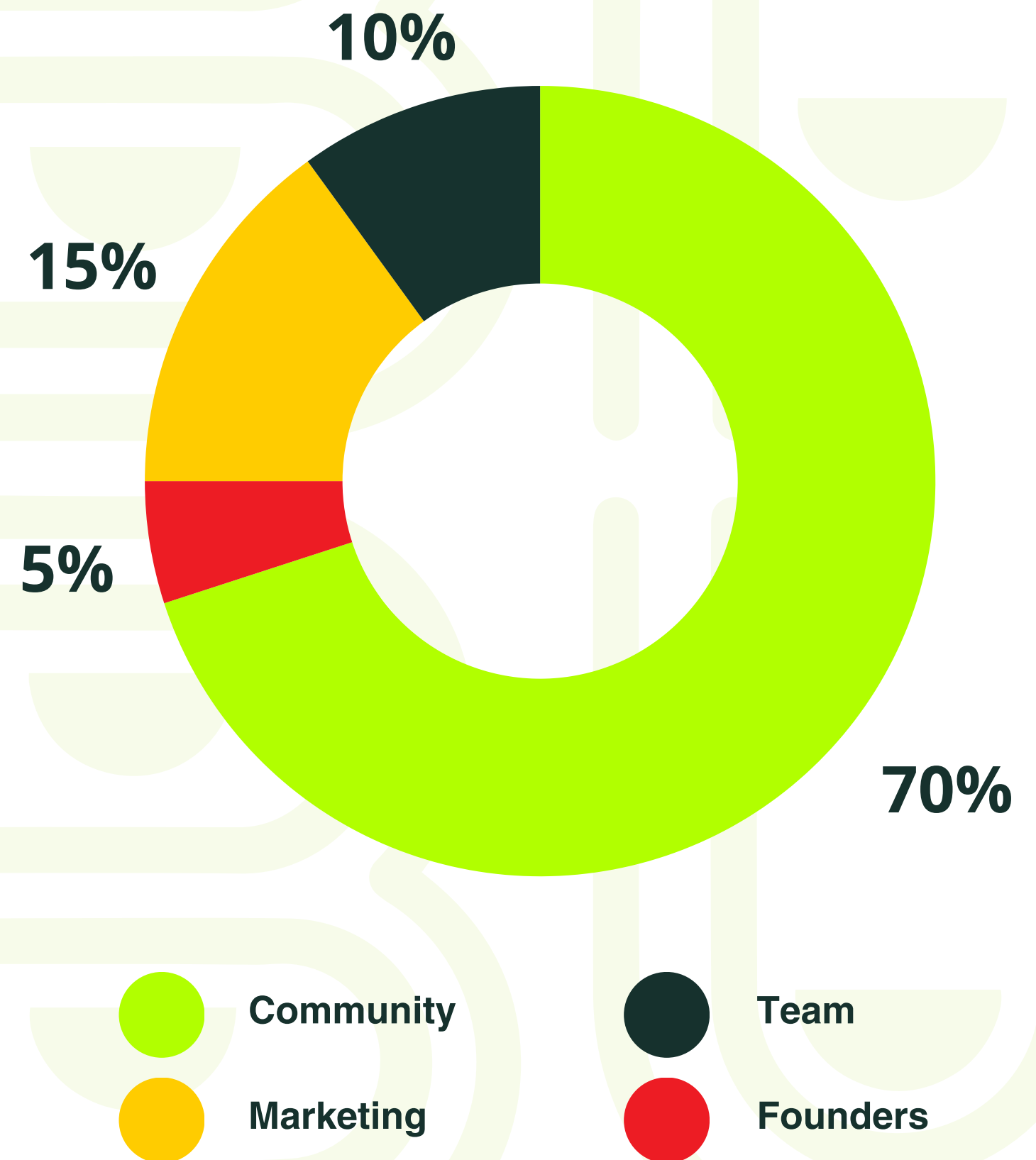
BABU Tokenomics

The Babu Project is a real world asset backed project. This means that the value of the project is generated outside of the blockchain and independent of adoption.

The project tokenomics are designed to create a strong community that holds 70% of Token distribution for you.

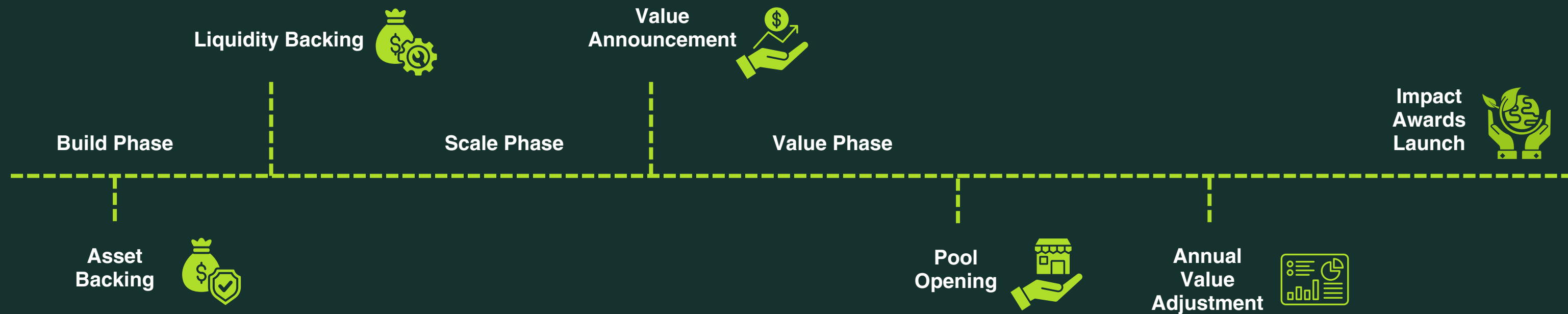
The Early Bird Launch has already attracted nearly 2.000 Community Members with Unique Wallets, meaning that there is a strong foundation.

To further increase trust, the founders, team and company have an additional lock-up period of 4 years to receive all of their Tokens and only receive 25% of their Tokens per year.





BABU ROADMAP



BUILD PHASE:

Babu is the umbrella for several communities that supported an early bird sale to launch the underlying reforestation and social impact project managed by the GRO Foundation.

GOAL:

- Carbon Project launch
- Project Validation Audit
- Project Listing on Registry

SCALE PHASE:

Babu aims to do its first Reward Airdrop to the Early Bird Community in September 2024 and introduce the BABU masks around the same time as a Pre-Sale offer to support the project long-term. Participants will be rewarded over a 20 year period but can trade their masks peer-to-peer as of 2025)

GOAL:

- Reward Token Asset backing
- Reward Token Airdrop - Q4 2024
- BABU Mask pre-sale - Q4 2024
- BABU Mask public sale - Bull Market 2025
